**Secretarial Compliance Report of R R Financial Consultants Limited for the financial year ended 31<sup>st</sup> March, 2023**

I have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by R R Financial Consultants Limited, having its Registered Office at 412-422, 4<sup>th</sup> Floor, Indraprakash Building, 21 Barakamba Road Central Delhi-110001.
